HORNET HIGHLIGHT - SHEA HERNANDEZ

Flour Bluff Primary Principal, Shea Hernandez, is assuming a new role at Flour Bluff High School. Beginning with the 2021-2022 school year, Ms. Hernandez will be an Assistant Principal at FBHS and assist the campus with drop-out recovery efforts through the district's newly created Hornet Learning Academy. This new initiative will focus on reaching students who have dropped out or are at-risk of dropping out of school and will provide opportunities for students to complete high school.

"Ms. Hernandez will transition to a new role that will lend her expertise to ensuring that students who found themselves struggling, especially

during this past year, will return and complete their high school careers," said Velma Soliz-Garcia, Flour Bluff ISD Superintendent of Schools. "I'm confident she will be an asset to Flour Bluff High School and will be instrumental in helping the district re-connect with Hornets that are at-risk of dropping out."



Ms. Hernandez has 22 years of educational experience. She began her teaching career in San Antonio ISD, where she also was a Campus Instructional Coordinator and Assistant Principal. In 2010, she led the PreK through 2nd grades and Headstart programs in West Oso ISD. She has been leading Flour Bluff Primary since 2015.

"No Matter what age or grade level I've worked with, I have always fallen in love with the students," said Shea Hernandez. "Kids have a curiosity for learning; it's hard for their energy not to be contagious. I know this will be true of high school as well. I am curious and look forward to learning a new role right alongside them."

Ms. Hernandez will begin her new role at Flour Bluff High School in July. The District expects to have a new principal named at Flour Bluff Primary later this summer.

NUTRITION KICKS-OFF HORNET MOBILE MEALS

We are excited to announce the kick-off to the "Hornet - Mobile Meals" program. As part of our summer seamless option, the Nutrition Department has mobilized to take meals out to our Flour Bluff community. The program allows us to serve anyone eighteen years of

MEETING WITH RISING TIDE MINISTRIES



Rising Tide Ministry would like to see if our Construction Program could assist with the projects. Mrs. Medley will meet with our Construction Program Instructors to see if students could be assigned throughout the year to assist and fulfill the obligations required of the new PTECH Grant that leads to an Early College High School for CTE.

Dale Rankin with the "Island Moon" inquired on the status of the property the District owns on the Island. Below is a response he was sent regarding the recent discussions around the use of the property...


There have been discussions regarding several projects including a vertically integrated Oceans Program that would entail the utilization of the 6.7 acres on the Island and our Wetlands. There are several committees that are involved in the future endeavors of the district. One committee is a curriculum committee that is specifically working on the curriculum design for a vertically aligned Oceans Program for grades PK-12 – this would expand our current Oceans programs at Intermediate and Junior High. Another committee that will be heavily involved is the Community Advisory Committee. These committees will meet again in August.

Our goal is to build partnerships with TAMUCC (Harte Institute), UTMSI, Texas State Aquarium, Padre Island National Seashore, Barney Davis TPWD Fish Hatchery, and Texas Sea Grant. In addition, we have discussed including Non-Governmental Organizations such as the Texas Sealife Center, Coastal Bend Bays and Estuaries, The Ark, and the Coastal Conservation Association.

Additionally, Mr. Rankin inquired on the members of the Oceans Integrated PK-12 Committee as well as the Community Advisory Council. He was sent the listing of the Oceans Committee members (see below) and will also be provided a listing of the Community Advisory Council next week.

TECHNOLOGY UPDATE

As part of the American Rescue Plan Act of 2021, Congress authorized the Emergency Connectivity Fund (ECF) through the schools and libraries universal service support program, commonly knows as the E-rate program. This is an additional funding opportunity from the annual E-rate program. E-rate's ECF program is designed to cover laptops, tablets, and broadband connectivity purchases for off-campus use by students who lack the necessary Internet access and/or devices. The maximum reimbursement per device is \$400.00, of which E-rate will cover at 100%. The application filing window opened on June 29 and will close on August 13. Flour Bluff ISD will be applying as follows:

Tablets and Laptops – A survey (https://www.surveymonkey.com/r/VSNLPP2) was sent out to the community on July 1st. A push was made through Facebook, Instagram, Twitter, and School Messenger, asking the community to take this survey. The response we get from this survey will be the

Once a device and vendor are chosen, a recommendation will be given to the board of trustees to approve the procurement. E-rate will make the reimbursement through their SAM.gov account.

Broadband Internet – TEA has started a program portal to help school districts apply for broadband Internet for economically disadvantaged students who currently do not have Internet. TEA has done an incredible amount of background work gathering data we will need to apply for this funding. This data includes maps, population studies, and working with Internet Service Providers. They will serve as our consultants free of charge. More information is forthcoming as to exactly which student families will benefit from this program.


