ZOOM ON THE HILL WITH SENATOR EDDIE LUCIO

Dr. Jesus Chavez, Executive Director of South Texas Association of Schools, scheduled a zoom meeting for Superintendents from South Texas to discuss legislative issues with Senator Eddie Lucio. Senator Lucio was instrumental in the movement of educators on the priority list



for COVID-19 vaccines. On March 17, the U.S. Department of Education announced that State Educational Agencies and school districts in Texas are set to receive a total of \$12.41 billion from the \$121.97 billion in federal aid allocated to education in the American Rescue Plan (ARP). Superintendents touched on the following talking points:

- 1. All expressed a unanimous front for local discretion of any additional federal funds that are intended for school districts.
- 2. We mentioned the need for resources to address the COVID Academic slide, but most importantly the need to utilize funds for social, emotional, and mental health needs of our students.
- 3. All expressed that funds should not be formulated as a one size fits all approach.
- 4. The biggest take away expressed by the panel was the need for the funds to be supplemental to our budgets and not supplanting the budget. If you recall, that was the case for the first round of funds.
- 5. We expressed that our goal as Superintendents has always been "Save where we can to spend where we must!"

STATS (SOUTH TEXAS ASSOCIATION OF SCHOOLS) MID-SESSION UPDATE

STATS invited Ms. Catherine Knepp with Moak, Casey & Associates presented a legislative update on public education funding, key school finance bills, and federal funding.



Topics of discussion: Hold Harmless Calculator, Federal funding update, and 87th Legislative session.

We held the first Benefits Committee meeting this week. Louise Day presented on the history of our plans and Gallagher and Associates had a presentation on the state of our plans and what factors drive the funding and benefit decisions. We had a lively discussion on concerns over the costs associated with our plans versus TRS and other districts. At the request of the committee members, Gallagher will be preparing a



plan comparison analysis with these other plans for the next meeting on April 12th. In addition, Louise provide a financial report since inception on our insurance fund. We will begin discussing what modifications can be made to our benefits for the September 1st renewal in order to achieve a more cost effective solution for our employees.

PTFCH GRANT

We have been working with Lisa Seiser a grant consultant from Region One to complete a P-TECH Grant to enhance the Construction Skills Trades pathway at the high school. Ms. Seiser has received all the information needed and has submitted the grant to TEA. If the district receives the grant the amount would be for \$150,000.



Excerpt from Grant Summary:

"Therefore, with grant funds, the district plans to offer a Construction Skills Trades pathway. This program involves training, education and hands-on opportunities in the building trades, such as electricians, carpenters, and plumbers, along with an opportunity to earn an Associates in Applied Science. Few high schools in the Corpus Christi area are partnering with IHEs (such as Del Mar College) to offer a Construction Skills Trade pathway of study, making it extremely inviting for Flour Bluff ISD to pursue these trades in the Coastal Bend region. Workforce Solutions Gulf Coast wage information shows plumbers earn a mean wage of about \$27 per hour, while carpenters make about \$21 per hour. This would be a new, special program that will include opportunities such as completing the actual process of building a "tiny home" intended to prepare Flour Bluff High School graduates to work in the much needed construction trades for various companies or provide the ability for graduates to start their own construction companies upon graduation or after their higher education degree program. This Construction Skills Trades pathway provides several career options as well as continuing education and additional occupations through an Associate's in Applied Science Degree in Building Maintenance or Construction Technology."



UPDATE ON VIRTUAL ACADEMY

FBISD learned that TEA will no longer fund remote learning after this school year. Legislation is being discussed at this time by our representatives and we are awaiting information from Austin. On March 23, James Crenshaw and Dr. Allison Schaum met with a representative from TXVN. The discussion included what would it take for FBISD to create a virtual academy. TXVN offers online courses at \$400.00 a course per semester or FBISD could send curriculum to TXVN. In turn they would vet the curriculum and house it on their platform. They also found out the state will only fund half of the ADA per student who decides they want to be a virtual learner. Dr. Schaum learned TEA wants any district who wants to offer

virtual learning to fill out an application. She will download the application to share with the curriculum department.

DISTRICT CALENDAR COMMITTEE UPDATE

On March 24th, the calendar committee reconvened to review eight resubmissions of Calendar B. The end goal of this meeting was to narrow down the calendar options from eight to two. Each committee member received a copy of all eight calendars to review independently, or in small groups. At the conclusion of the examination process, voting



members were then asked to turn in their top two calendar picks. In the presence of the entire committee, two ad hoc members tallied the collected calendars to determine the two calendars with the most votes. The two calendars were then submitted for recommendation to the Superintendent. With the Superintendent's approval, we will meet with the DEIC next week to inform them of the two calendar options to survey staff, students, parents, and community. A recommendation to approve the 2021-2022 academic calendar will be presented to the school board at the April special board meeting.

FBISD COVID-19 VACCINE CLINIC


