This addendum is being issued to all Contractors who have been issued Drawings and Specifications after making the necessary deposit, to all Plan Rooms issued Drawings, and to the Owner.

Care has been taken to make reference to all items being revised, added, deducted, or a clarification of a question. However, any item called for in the Addendum, but not cross referenced to every possible item shall in no way relieve the Contractor of responsibility to comply with all items in the Addendum.

SPECIFICATION ITEMS:

- **Item S-1** Refer to Specification Section Division 1 AIA 201-2017 General Conditions of the Contract for Construction.
 - 1. The Owner's designated representative for the project is Joseph Guidry Executive Director of Operations.
- **Item S-2** Refer to Specification Section 27 51 23 Intercommunication System.
 - 1. Insert new paragraph 1.6.B which reads: "Contractor shall provide an estimate for a service maintenance contract to the Owner at end of project."
- **Item S-3** Refer to Specification Section 27 51 23 Intercommunication System.
 - 1. Insert new paragraph 1.11.C which reads: "Contractor shall update existing firmware for all existing head-end equipment, and test all equipment after such firmware updates are complete to ensure the system functions normally."

PRE-PROPOSAL MEETING ITEMS:

Question #1: To whom shall the RFI's be sent?

Response #1: Send all RFI's to Arti Bhakta (abhakta@flourbluffschools.net) with FBISD.

Question #2: Is it permissible to install the new system first and complete demolition after the

new installation is completed?

Answer #2: It is permissible to install the new system first and complete the demolition after

the new system installation is completed. This condition is limited to corridors only, all classrooms, offices, and the like shall have all components demolished prior to

the installation of the new system.

Question #3: Is there a wage scale for the project? If so, shall we use the Laborer classification?

Answer #3: Refer to the Specifications for the wage scale. According to the Davis-Bacon Act,

intercommunication system technician is listed under the electrician labor rates. Technicians utilized for the project shall be paid the rate for an electrician included

within the wage scale within the Specifications.

Question #4: Shall we reuse existing ceiling tiles that are not compromised, damaged, or

sagging?

Answer #4: Yes, utilize existing ceiling tiles that are not compromised, damaged, or sagging.

New ceiling tiles will be furnished by FBISD.

Question #5: Will we receive a badge to utilize while working at the facilities?

Response #5: Generally, all contractors must check in every two-weeks to receive a printed

badge to wear on their clothing while working at FBISD. FBISD will determine if they can provide other means of identification for the contractors while working at

the facilities.

Question #6: Will FBISD issue keys to the contractor to utilize while working at the facilities? If

so, can two sets of keys be issued?

Answer #6: Yes, FBISD will issue two sets of keys for the contractor to utilize while working at

the facilities.

Question #7: Will FBISD turn off any security systems at the facilities, or will they provide a

temporary code for the contractor to use?

Answer #7: FBISD will provide a temporary code to the contractor to utilize.

Question #8: Shall we utilize a FBISD dumpster to dispose of material?

Answer #8: This is a turn-key project, and the contractor shall be responsible for disposing of

all material demolished.

Question #9: Can we have our materials shipped to FBISD to receive?

Answer #9: No, the contractor is responsible for shipping, storing, and delivering materials to

the FBISD facilities.
